

ACTION PLAN

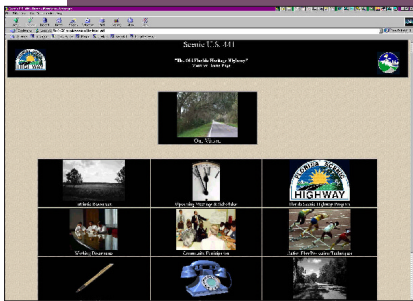
